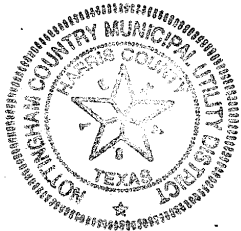
The Board of Directors of Nottingham Country Municipal Utility District will hold a regular meeting on Monday, October 17, 2022, at 11:30 a.m., at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2600, Brazos Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:


1. Comments from the public.
2. Approve Minutes of prior meetings.
3. West Harris County Regional Water Authority matters.
4. Financial and bookkeeping matters, including payment of bills and review of investments.
5. Tax assessment and collection matters, including:
 - a. delinquent tax collections, installment agreements, payment of tax bills, and requests for waivers of penalties and interest; and
 - b. conduct public hearing regarding District's tax rate, adopt Order Levying Taxes, and authorize execution of Amendment to Information Form.
6. Operation of District facilities, billings, meter maintenance program, and repairs and maintenance, including:
 - a. customer correspondence; and
 - b. update on system-wide leak detection inspection.
7. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
8. Engineering matters and capital improvement projects, including authorize design, approve plans and specifications, authorize advertisement for bids, review bids and approve award of contract, approve pay estimates, time extensions and change orders, and final acceptance, as appropriate, for the following:
 - a. wastewater treatment plant improvements;
 - b. sanitary sewer rehabilitation program;
 - c. District Capital Improvement Plan Budget update;
 - d. development of Geographic Information System;
 - e. proposals for rehabilitation of District facilities and engineering work, including storm water channel improvements;
 - f. development in the District;
 - g. deeds, easements, consents to encroachment, requests for service, or utility commitment letters;
 - h. update on facility assessment to evaluate implementation of flood mitigation measures, repairs, and improvements at District
